

## ENFORCEMENT PROGRAM STATISTICS: 2010

*The following statistics highlight ARB's Enforcement Program achievements in 2010:*

- 3,701 cases/citations closed (3,517 for mobile source programs and 184 for stationary source programs);
- Over \$12.7 million in penalties collected;\*
- 3,677 of these cases/citations were closed administratively for over \$8.6 million;
- 23 of these cases were closed via civil litigation for over \$2.8 million;
- 1 case closed via criminal prosecution with \$1.2 million in restitution; and
- Funded 141 Supplemental Environmental Programs (SEPs) totaling \$336,672 from penalties collected from these enforcement actions.

The statistics for the Mobile Source Enforcement Program are as follows:

- 3,517 cases/citations closed for over \$9.5 million\*
- 248 diesel fleet and exhaust retrofit cases closed for over \$1.3 million;
- 3,145 in use diesel program citations closed for over \$1.4 million;
- 789 mobile Transport Refrigeration Unit violations closed for \$733,993 and 26 TRU fleet cases closed for \$228,275;
- 14,784 heavy-duty vehicles inspected for smoke emissions and tampering, with 152 violations closed for \$28,700;
- 6,456 inspections for commercial vehicle and school bus idling conducted, with 763 violations closed for \$196,237;
- 91 field inspections of solid waste collection vehicles, with 24 violations closed and \$1,200 collected and 20 fleetcases closed for \$52,720;
- 13,247 heavy-duty vehicles inspected for engine certification labeling requirements, with 825 violations closed for \$190,399 ;
- 573 delinquent violations (multiple programs) closed for \$231,895;
- 124 general mobile source cases/citations closed for over \$6.7 million;
- 6 illegal aftermarket performance parts cases closed for \$2,134,500;
- 11,855 inspections for off-road use only, non-taxed, red-dyed diesel fuel conducted for on-road vehicles, with 10 violations;
- 10,012 vehicle inspections conducted in Environmental Justice areas with 2,171 violations documented;
- 141 California Community College CCDET compliance training classes held.

The statistics for the Stationary Source Enforcement Program are as follows:

- 184 cases/citations closed for over \$3.2 million;\*
- 7 fuels cases closed for various violations for over \$90,400;
- 1,141 cargo tanks inspected for proper certification and leak detection with 32 cases closed for \$16,000;
- 51 samples of portable fuel containers and spouts were collected during inspections, with 2 cases closed for \$93,000;
- Over 1.6 billion gallons of gasoline and over 379 million gallons of diesel fuel represented in sampling;
- 2,256 consumer product samples gathered during inspections, with 72 cases closed for over \$2.9 million;
- 3,446 inspections conducted at ports, rail yards, and marinas, including 2,694 inspections of locomotives resulting in 24 violations issued and 52 violations closed for \$9,200; 328 Cargo Handling Equipment inspections with two violations closed for \$28,500; 210 Commercial Harbor Craft inspections and six violations closed for \$2,000; 313 Ocean Going Vessel inspections with 18 violations issued for \$69,750; and 29 marina fuel dock inspections;
- 218 Composite Wood Product inspections; and
- 84 asbestos inspections conducted; 5 complaints investigated and 8 asbestos violations documented.

The statistics for the Training and Compliance Assistance Programs are as follows:

- 337 classes or multi-day training programs offered, representing 8,829 student days of training; and
- Over 4,990 publications distributed, plus 217,204 webpage views on publications.
