

## 2011 ENFORCEMENT STATISTICS

*The following statistics highlight ARB's Enforcement Program achievements in 2011:*

- 3,536 enforcement actions closed
- Over \$6.6 million in penalties assessed<sup>1</sup>
- \$293,383 in Supplemental Environmental Programs (SEPs) awarded from the settlement of 147 diesel cases
- 8,019 vehicle inspections conducted in Environmental Justice areas
- Significant Cases:
  - \$750,000 settlement via the San Bernardino DA's Office with Asian importer of illegal vehicles
  - \$560,000 settlement for sales of aftermarket catalytic converters without an Executive Order
  - \$534,000 settlement for SWCV<sup>2</sup> and PSIP<sup>3</sup> failure to install legally required emission-reduction devices and properly self-inspect diesel trucks
  - \$510,000 settlement for importation and sales of non-California certified motorcycles and off-highway recreational vehicles to California residents

### **Case Investigation and Resolution Programs: 388 cases closed and \$5,050,353 in penalties:**

- Consumer Products: 31 cases closed for \$213,000
- Heavy Duty Diesel Fleet Programs (Statewide Diesel Fleet Programs, Specialized Diesel Fleet Programs, Diesel Equipment Programs): 307 cases closed for \$1,828,853
- Vehicle Engine and Parts Programs: 50 cases closed for \$3,008,500

### **Field Operations Programs: 55,942 inspections, 3,148 enforcement actions, \$1,601,956 in penalties assessed:**

- Cargo Tank Program: 389 inspections completed, 15 enforcement actions closed, \$7,003 in penalties assessed
- Fuels Programs: 13,313 inspections completed, 21 enforcement actions closed, \$289,000 in penalties assessed
- Heavy Duty Diesel Field Inspection Programs (Specialized Fleet and Equipment Program, Statewide Truck and Bus Program): 35,990 inspections completed, 2,971 enforcement actions closed, \$911,603 in penalties assessed
- Marine Programs: 3,792 inspections completed, 112 enforcement actions closed, \$384,350 in penalties assessed
- Railroad MOU Programs: 2,458 inspections completed, 29 enforcement actions closed, \$10,000 in penalties assessed

### **Mobile Source Program Highlights:**

- 1,500 Transport Refrigeration Unit (TRU) violations documented
- Over 21,000 heavy-duty vehicles inspected for smoke emissions & tampering

### **Ports and Railyards Highlights:**

- 6,250 inspections conducted at ports & rail yards and 152 violations documented

### **Motor Vehicle Fuels Highlights:**

- 2,463 motor vehicle fuels samples collected and 15,914 fuels analyses conducted
- Over 2.2 billion gallons of gasoline and 484 million gallons of diesel fuel represented in sampling

### **Training Highlights:**

- 274 training courses (including California classroom training, Visible Emissions Evaluation training, and ARB staff training) held and 9,592 students enrolled
- 53 California Council on Diesel Education and Technology (CCDET) classes were funded from \$293,383 in SEPs
