

Compliance Instrument Tracking System Service Registrants Report September 30, 2015

The “Legal Name” is the entity’s legal name as entered by the registrant. If a voluntary entity is an individual, the individual’s name is listed as the “Legal Name.” The “Entity ID” is the unique identification number for each entity. “Entity Type” is the status of the entity as a covered entity or voluntary (general) participant in the Cap-and-Trade Program. “Mandatory Reporting GHG ID(s)” is the reporting ID of the facilities subject to the Mandatory Greenhouse Gas Reporting Regulation that are associated with the entity. This list contains entities registered in CITSS pursuant to California’s Cap-and-Trade Regulation and does not include entities registered in a linked jurisdiction’s program.
