

**Funding Agricultural Replacement Measures for Emission Reductions  
(FARMER) Program:  
Final Fiscal Year 2019-20 District Funding Allocations**

The 2019 Budget Act included a restriction on committing more than 75 percent of the budget appropriations for Greenhouse Gas Reduction Fund programs, including the FARMER Program, until the Department of Finance made a final determination about funding availability. Due to lower than anticipated auction results in the May 2020 Cap-and-Trade auction, funding for the fiscal year 2019-20 FARMER Program was reduced. The table below shows the final fiscal year 2019-20 district funding allocations based on the final 2019 Budget appropriation for the FARMER Program after the Department of Finance’s determination of available funds pursuant to Section 15.14 of the Budget Act of 2019.
