#### **Current Status of Clean Mobility Investments**

Clean Mobility Options Voucher Pilot Program (CMO)	\$99 million	<ul> <li>7 existing or completed regional clean mobility pilots</li> <li>36 community transportation needs assessments</li> <li>37 mobility projects</li> <li>Through Statewide Administrator (CALSTART)</li> </ul>
Clean Mobility in Schools (CMIS)	\$46.9 million	<ul> <li>4 existing grants</li> <li>2 new awards from FY 2022-23 Request for Applications (RFA)</li> </ul>
Sustainable Transportation Equity Project (STEP)	\$61.7 million	<ul> <li>8 existing Planning Grants</li> <li>5 existing Implementation Grants</li> <li>3 new awards from FY 2022-23 RFA</li> </ul>
Planning and Capacity Building (Planning)	\$5 million	<ul> <li>7 new awards from FY 2022-23 RFA</li> <li>Through Statewide Administrator (Data for Social Good)</li> </ul>



#### Fiscal Year 2023-24 Budget and Staff Recommendations

- \$10 million available for Planning
- \$50 million available for CMO, CMIS, and STEP

Subprogram	Recommended Fiscal Year 2023- 24 Funds	Recommendation Details
Planning	\$10 million	<ul> <li>Fund applications through a new Planning RFA and fully fund a previously partially awarded application from FY 2022-23 RFA</li> <li>\$2.4 million for Statewide Administrator and Planning, CMIS, and STEP technical assistance</li> </ul>
СМО	~\$16.7 million	<ul> <li>Add to current Statewide Administrator agreement (CALSTART)</li> <li>Add funds to current projects and to the Clean Mobility Equity Alliance</li> </ul>
CMIS and STEP	~\$32.3 million	<ul> <li>Fund applications from FY 2022-23 RFA, including fully funding previously partially awarded applications and additional applications from the previous application pool</li> </ul>
