The California Air Resources Board (CARB) is submitting to the U.S. Environmental Protection Agency (U.S. EPA) the South Coast Air Basin (South Coast) *Contingency Measure Plan, Planning for Attainment of the 1997 80 ppb 8-Hour Ozone Standard in the South Coast Air Basin* (Ozone SIP Update) as a revision to the California State Implementation Plan (SIP). The South Coast Air Quality Management District (SCAQMD) adopted the Ozone SIP Update on December 6, 2019, and CARB adopted the Ozone SIP Update on December 12, 2019.

The Ozone SIP Update submittal consists of the following items:


