### **Focus of the Workshops**

**Investment Plan:** To guide the investment of Cap-and-Trade auction proceeds, the Department of Finance, in consultation with the Air Resources Board and other State agencies, is required to submit a three year Investment Plan to the Legislature that identifies priority investments to help California achieve its greenhouse gas reduction goals, while realizing additional health, economic, and environmental benefits. A concept paper will present preliminary high level ideas and draft funding priorities for public discussion to inform development of the Second Investment Plan covering Fiscal Years 2016-17 through 2018-19.

**Funding Guidelines:** The Greenhouse Gas Reduction Fund holds the State's portion of auction proceeds, generated by California's Cap-and-Trade Program. Each fiscal year, the Governor and Legislature determine which State agencies and programs will receive appropriations from this Fund, to invest in projects that reduce greenhouse gases. Greenhouse Gas Reduction Fund programs are administered by over a dozen State agencies and each agency is responsible for implementing its own program.

State law requires the Air Resources Board to develop guidance for all State agencies that receive appropriations from the Greenhouse Gas Reduction Fund, including guidance on reporting, quantification methods, and maximizing benefits to disadvantaged communities. In response, Air Resources Board staff is developing Funding Guidelines to help these agencies use their appropriations in a way that reduces greenhouse gases, furthers the purposes of Assembly Bill 32 (Núñez, Chapter 488, Statutes of 2006), maximizes benefits to disadvantaged communities, and meets the other statutory requirements.

## **Background**

The State proceeds from the Cap-and-Trade Program (title 17, California Code of Regulations, section 95800 et seq.) provide an opportunity for California to invest in climate action, with an emphasis on our most disadvantaged communities. These investments are financing programs and projects that further the objectives of AB 32 by reducing greenhouse gas emissions in the State; delivering benefits to disadvantaged communities; and maximizing, where feasible, economic, health, and environmental co-benefits.
