### NOTICE OF PUBLIC MEETING TO PRESENT THE REVISED DRAFT CAP-AND-TRADE AUCTION PROCEEDS THIRD INVESTMENT PLAN

The California Air Resources Board (CARB or Board) will conduct a public meeting at the time and place noted below on the revised draft Cap-and-Trade Auction Proceeds Third Investment Plan: Fiscal Years 2019-20 through 2021-22 (revised draft Investment Plan).

This item will be presented at a meeting of the Board, which will commence at 9:00 a.m. on November 15, 2018, and may continue at 8:30 a.m. on November 16, 2018. Please consult the agenda for the meeting, which will be available at least ten days before November 15, 2018, to determine the day on which this item will be presented.

#### **Background**

California Climate Investments is a statewide initiative that puts billions of Cap-and-Trade dollars to work reducing greenhouse gas (GHG) emissions, strengthening the economy, and improving public health and the environment—particularly in disadvantaged communities, low-income communities, and low-income households.

Since 2012, the Governor and the Legislature have appropriated over \$8 billion in California Climate Investments funding received through the State's Cap-and-Trade allowance auctions. The revised draft Investment Plan will help inform funding decisions for the next three years.

The revised draft Investment Plan identifies future investment priorities and strategies to expand the scope and reach of the existing suite of California Climate Investments programs. Priorities include continued focus on GHG emission reductions, increased community-level projects and participation, greater funding certainty to allow longer-term planning of the funds, and an increased emphasis on other economic, environmental, and public health benefits.

The revised draft Investment Plan incorporates feedback from written comments and two public workshops on the Draft Third Investment Plan held in Los Angeles and Fresno in September, 2018.

The Investment Plan must identify the State's GHG reduction goals, analyze gaps in current state strategies for GHG reductions, and identify priority investments. The first two investment plans were submitted to the Legislature in 2013 and 2016, respectively.

California Climate Investments are part of California's comprehensive, multi-year Cap-and-Trade Program designed to reduce GHG emissions in California. California Climate Investments are funded through the Greenhouse Gas Reduction Fund (GGRF), which holds the State proceeds from the Cap-and-Trade Program (title 17, California Code of Regulations, section 95800 et seq.). California Climate Investments programs are administered by over 19 State agencies and each agency is responsible for administering its own program. Inclusion of a concept in the Third Investment Plan is not a guarantee of funding.
