## Notice of Public Meeting of the California Air Resources Board, the California Transportation Commission, and the California Department of Housing and Community Development

The California Air Resources Board (CARB or Board) will host a joint public meeting between CARB, the California Transportation Commission (CTC or Commission), and the California Department of Housing and Community Development (HCD or Department) as noted below.

Date: November 4, 2021

Time: 9:00 A.M.

Remote Option: Zoom

Please see the public agenda which will be posted ten days before the November 4, 2021, joint meeting for direction regarding this remote-only joint meeting.

This meeting is the second of two annual joint meetings between these agencies in 2021 to coordinate interagency efforts to implement policies that jointly affect transportation, housing, air quality, and climate. The meeting will focus on inter-agency work on equity, housing, and related efforts to reduce vehicle miles traveled (or VMT) in order to meet California's climate and air quality commitments.

### Background

In June 2018, CARB and CTC began meeting twice per calendar year to coordinate implementation of transportation programs and policies, pursuant to Assembly Bill (AB) 179 (Cervantes, Chapter 737, Statutes of 2017). In 2019, AB 185 (Grayson, Chapter 534, Statutes of 2019) added a representative from HCD to the joint meetings and expanded the scope of these meetings to include discussions of policies that jointly affect transportation, housing, and air quality.

Joint meetings are more informal than Board or Commission meetings. Presentations will be designed to facilitate open dialogue amongst the Board, Commission, HCD, and the public. We encourage public participation, and there will be dedicated time allotted for public comments throughout the meeting.

This joint meeting of the Board, the Commission, and HCD is separate from CARB's November 19, 2021, Board meeting and will not be on CARB's November Board agenda.

## **Submittal of Comments**

Interested members of the public may present comments orally or in writing during the joint meeting and may provide comments by postal mail or by electronic submittal before the meeting. To be considered during the joint meeting, written comments not submitted during the meeting, must be received **no later than October 25, 2021**, and addressed to the following:
