This joint public meeting is convened to coordinate CARB, CTC, and HCD's implementation of policies that jointly affect transportation, housing, air quality, and climate. The meeting will focus on aligning the agencies' actions to deepen that work and better achieve the State's climate, transportation, and housing goals.

Background

In June 2018, CARB and CTC began meeting twice per calendar year to coordinate implementation of transportation programs and policies, pursuant to Assembly Bill (AB) 179 (Cervantes, Stats. 2017, ch. 737). In 2019, AB 185 (Grayson, Stats. 2019, ch. 534) added a representative from HCD to the joint meetings and expanded the scope of these meetings to include coordinating the implementation of policies that jointly affect transportation, housing, and air quality.

Joint meetings are more informal than Board or Commission meetings. Presentations will facilitate open dialogue amongst the Board, the Commission, HCD, and the public. We encourage public participation and there will be dedicated time allotted for public comments.

This joint meeting of the Board, the Commission, and HCD is separate from CARB's November 17-18, 2022, Board meeting.

Submittal of Comments

Interested members of the public may present comments orally or in writing during the joint meeting and may provide comments by postal mail or by electronic submittal before the meeting.
