This joint meeting is convened to coordinate the Board, Commission, and Department's implementation of policies that jointly affect transportation, housing, air quality, and climate. The meeting will focus on aligning the agencies' actions to deepen that work and better achieve the State's climate, transportation, and housing goals.

Background

Government Code section 14516 directs the Board, Commission, and Department to meet at least twice per calendar year to coordinate their implementation of policies that jointly affect transportation, housing, and air quality, including interagency efforts.

Joint meetings are more informal than Board or Commission meetings. Presentations will facilitate open dialogue amongst state agencies and the public. We encourage public participation and there will be dedicated time allotted for public comments.

This joint meeting is separate from CARB's other scheduled Board meetings in November.


