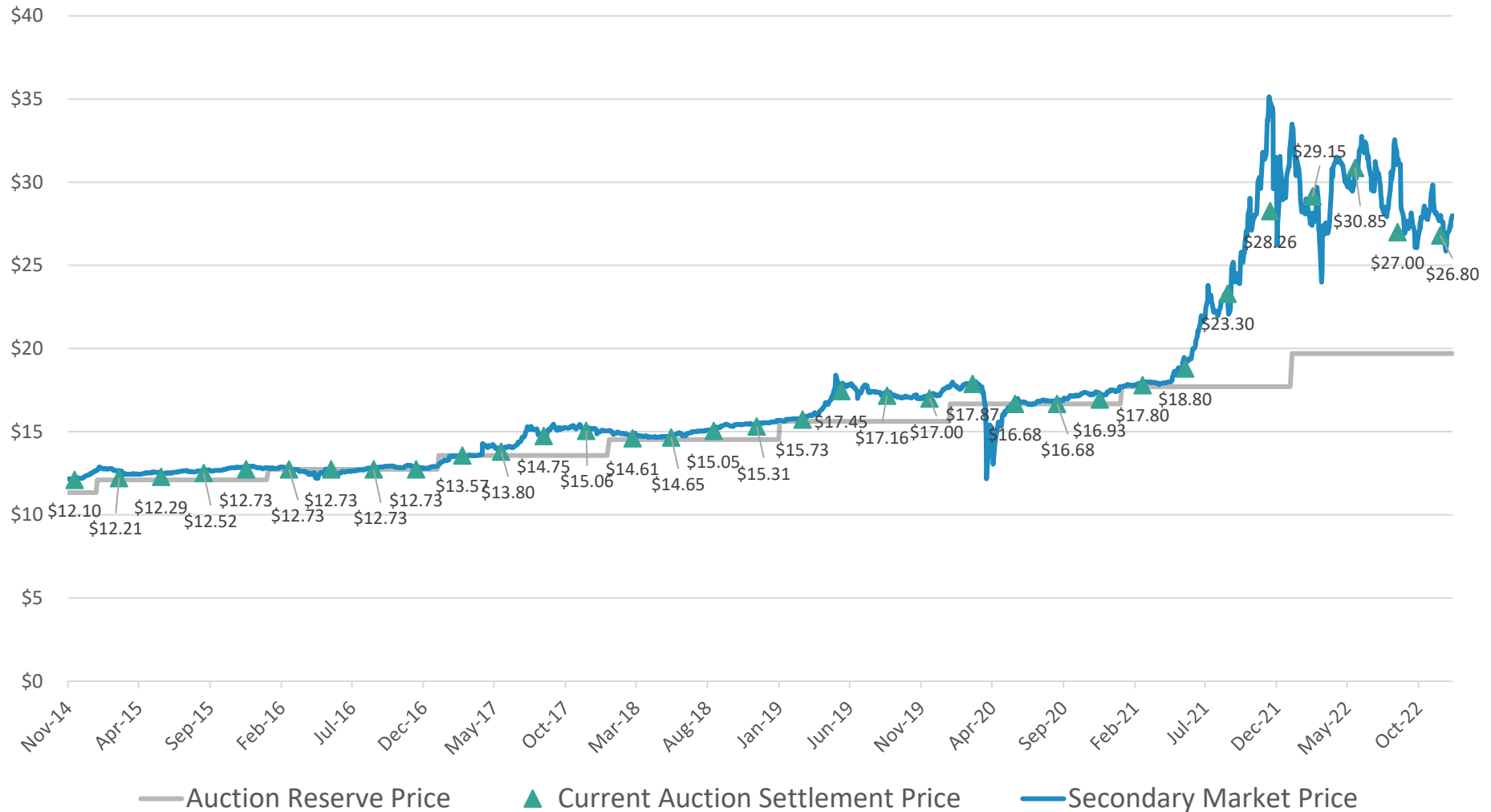


California and Québec Carbon Allowance Prices
