**BE IT FURTHER RESOLVED:** That for the listed engines are permitted conditionally on final approval by the Office of Administrative Law of the amendments to the Regulations For New Emission Standards, Fleet Requirements, And Test Procedures For Forklifts And Other Industrial Equipment (13 CCR Section 2433(c) (certification and test procedures), 13 CCR Section 2434 (emission control labels), and 13 CCR Sections 2435 and 2436 (emission control system warranty)) adopted by the Board at the May 25, 2006 public hearing. In the event that the amendments do not become effective, engines in this engine family will be deemed uncertified.

**BE IT FURTHER RESOLVED:** That the listed engine models are conditionally certified based on certification levels estimated by extrapolating partial durability test data.
