BE IT FURTHER RESOLVED: That because the listed engine models shall be used exclusively in wintertime snowblower and/or ice auger products only (13 CCR Section 2403(b)(5)), the equipment is exempt from complying with 13 CCR, Chapter 15, Article 1 (evaporative emission requirements for off-road equipment).

Engines certified under this Executive Order must conform to all applicable California emission regulations.

Quarterly reports of engines produced in this engine family for sale in California shall be submitted to the Executive Officer no later than 45 days after the end of each calendar quarter.

This Executive Order is only granted to the engine family and model-year listed above. Engines in this family that are produced for any other model-year are not covered by this Executive Order.
