EXECUTIVE ORDER G-00-057

WHEREAS, on March 23, 2000, the Air Resources Board (Board) conducted a public hearing to consider amendments to the Agricultural Burning Guidelines, set forth in sections 80100, 80101, 80102, 80110, 80120, 80130, 80140, 80145, 80150, 80155, 80160, 80170, 80175, 80179, 80180, 80190, 80200, 80210, 80230, 80240, 80250, 80260, 80270, 80280, 80290, 80300, 80310, 80311, 80320, and 80330, title 17, California Code of Regulations (CCR);

WHEREAS, following the public hearing the Board adopted Resolution 00-8, in which the Board approved the amendments of sections 80100, 80101, 80102, 80110, 80120, 80130, 80140, 80145, 80150, 80155, 80160, 80170, 80175, 80179, 80180, 80190, 80200, 80210, 80230, 80240, 80250, 80260, 80270, 80280, 80290, 80300, 80310, 80311, 80320, and 80330, title 17, CCR, as set forth in Attachments A and B thereto;

WHEREAS, Resolution 00-8 directed the Executive Officer to adopt the regulations, after making them available to the public for a period of 15 days, provided that the Executive Officer shall consider such written comments as may be submitted during this period, shall make modifications as may be appropriate in light of the comments received, and shall present the regulations to the Board for further consideration if he determines that this is warranted;

WHEREAS, the approved regulations were made available for public comment for a 15-day period, with the changes to the originally proposed text clearly indicated, in accordance with the provisions of title 1, CCR, section 44;

WHEREAS, all written comments received during the 15-day period have been considered by the Executive Officer and do not require modification nor reconsideration by the Board of the approved regulations;

WHEREAS, the reporting requirements of the approved regulations which apply to small businesses are necessary for the health, safety, and welfare of the people of the State.

NOW, THEREFORE, IT IS ORDERED that the recitals and findings contained in Resolution 00-8 are incorporated herein.

IT IS FURTHER ORDERED that the amendments to sections 80100, 80101, 80102, 80110, 80120, 80130, 80140, 80150, 80155, 80160, 80170, 80180, 80200, 80210, 80230, 80240, 80250, 80260, 80270, 80280, 80290, 80300, 80310, 80311, 80320, and 80330, the repeal of section 80175, and the adoption of sections 80145 and 80179 of title 17, California Code of Regulations (CCR), are hereby adopted as set forth in Attachment 1 hereto.
