All Submittals Require a Legible Photo of:

- DMV Vehicle Registration Card or Registration Renewal notice
- VIN/GVWR label (typically located on the driver side door or door jamb)
- License plate with side of the vehicle visible
- Entire left side of the vehicle with doors closed
- Entire right side of the vehicle with doors closed

In addition to the photos listed above please include the additional, legible, photos listed below if you're applying for:

Personal, non-commercial pickup truck with a pickup bed under 9 feet, and GVWR under 19,500 lbs.:

No additional photos needed

Vehicle used exclusively for towing a habitable trailer for non-commercial private use:

- Photo of the DMV trailer registration card or Registration renewal notice
- Photo of the interior of the trailer verifying it is for human habitation (eating area, sleeping area, toilet, etc.)

Motorhome for non-commercial private use including vehicles converted to a motorhome:

• Photo of the interior of the motorhome verifying it is for human habitation (eating area, sleeping area, toilet, etc.)

2010 or older chassis with original engine year that is the same year or newer than the chassis:

- Photo of the engine compartment that still shows part of the vehicle's exterior
- Photo of Emission Control Label (ECL) to verify the Engine Family Name

Dedicated snow-removal vehicle:

Photo of snow removal equipment including the permanent attachment points to the vehicle

2010 or older chassis with a repowered engine:

- Photo of the engine compartment that includes part of the vehicle's exterior
- Photo of Selective Catalytic Reduction (SCR) system installed
- Photo of Emission Control Label (ECL) to verify the Engine Family Name
- Photo of Particulate Matter (PM) Filter
- Photo of Diesel Exhaust Fluid (DEF) Tank or Engine Family Name (EFN) if no DEF Tank
- Photo of gauge cluster and warning lights with instrument panel lights on (engine running)

Private School bus that is not used as "school pupil activity bus":

- Copy of contract with education institution
- Photo of Particulate Matter (PM) Filter
- Photo of Emission Control Label (ECL) to verify the Engine Family Name
- Photo of Particulate Matter (PM) Filter label on engine

Diesel engine that has been converted exclusively to CNG/LNG fuel:

- Photo of Emission Control Label (ECL) to verify the Engine Family Name
- Photo of the engine compartment (under the hood)
- Photo of fuel cap, including fuel tank if not concealed

Diesel engine that has been converted exclusively to Propane/LPG fuel:

- Photo of Emission Control Label (ECL) to verify the Engine Family Name
- Photo of the engine compartment (under the hood)
- Close-up photo of fuel cap for Propane or LPG fuel
- Photo of fuel cap, including fuel tank if not concealed

Diesel engine that has been replaced exclusively with an Electric engine:

Photo of the engine compartment (under the hood)

Diesel engine that has been replaced exclusively with a Gasoline engine:

- Photo of Emission Control Label (ECL) to verify the Engine Family Name for the gasoline engine
- Photo of the engine compartment (under the hood)
- Photo of fuel cap, including fuel tank if not concealed
