- CARB research program created by the Legislature in 1971
- External contracts and in-house research
- Budget for external contracts \$4-8 M annually
- Multiple coordination mechanisms
 - ARB leverages \$5 from collaborators for every \$1 of ARB research funds spent



Research to Inform Policy



Triennial Research Planning

- The Triennial Plan will be released every three years
- The Triennial Plans will outline broad research initiatives that represent the agencies' anticipated research needs over the next three fiscal years
- The Triennial Plan will be used to identify projects to be funded each year
- Staff will continue to bring lists of projects to the Board for approval every fiscal year

Objectives of Triennial Research Plan

- Guide research funding to produce timely and credible science to inform key decisions needed to meet air quality, climate goals, environmental justice, and public health goals
- Improve coordination and identify co-funding and leveraging opportunities with other research funding organizations
- Provide greater transparency and stakeholder involvement in the planning process
- Allow for more responsive research proposals from universities and other groups
- Provide increased flexibility to adjust to budget changes and opportunities

Schedule for Plan Development

November 2017 - January 2018– Develop draft research initiatives with CARB staff, Board Members, and the EJAC Data & Modeling Workgroup

January 26, 2018 – Public Workshop on the Draft Initiatives for the Triennial Research Plan

February to March – Coordinate



Contract Development


- Develop solicitations for proposed projects*
