Background

Assembly Bill (AB) 617 was signed into law in July 2017. CARB established the Community Air Protection Program to implement AB 617, which requires new community-focused action to reduce air pollution and improve public health in communities that experience disproportionate burdens from exposure to air pollutants.

The Board approved the *Community Air Protection Blueprint for Selecting Communities, Preparing Community Emissions Reduction Programs, Identifying Statewide Strategies, and Conducting Community Air Monitoring* (Blueprint), which meets statutory requirements for the statewide strategy and monitoring plan, at the September 2018 Board meeting. This Blueprint includes: processes and criteria for identifying and selecting impacted communities; statewide strategies (including new regulations) to reduce emissions of criteria air pollutants and toxic air contaminants; and requirements for the development of community air monitoring systems and community emissions reduction programs.
