- 1. Company Name Legal name of entity, business, organization, agency or private individual that operates the registered portable engine or equipment unit.
- 2. *PERP Registration Number* Enter the registration number from the registration certificate or sticker.
- 3. *Reporting Year* Enter the year for which the equipment unit operation is being reported.
- 4. *Total Material Throughput* Enter the total annual material throughput for equipment units. Use the units as listed in the Operating Conditions or the units listed below for the type of equipment.
