

## DRAYAGE TRUCK EXEMPTION APPLICATION FORM

The California Air Resources Board's In-Use On-Road Diesel-Fueled Heavy-Duty Drayage Trucks Regulation (California Code of Regulations., title 13, section 2027) provides a process to exempt certain drayage trucks from the emission reduction requirements. All exempted trucks must meet one or more of the exemption criteria and submit the required documentation in section (D) and complete sections (A-E) of this form to be considered for an exemption. Drayage regulatory exemptions apply to the drayage truck regulation only. Trucks that transport containers to or from California's ports or intermodal rail facilities are not eligible for this exemption.

Select one or more:

- Class 6 or smaller (manufacturer's GVWR 26,000 or less). Submit a copy of the DMV registration for verification.
- Non-diesel fueled (e.g. LNG fueled). Submit a copy of the DMV registration for verification.
- Emergency vehicle. Submit a picture of the vehicle for verification.
- Military tactical support vehicle. Submit a picture of the vehicle and a copy of the DMV registration for verification.
- Off-road (e.g. yard trucks, mobile cranes). Submit a picture of the vehicle for verification.
- Dedicated use vehicle: Power take off (tractor and trailer treated as a uni-body) or uni-body vehicles that do not have separate tractor and trailers (e.g. fuel delivery vehicles, concrete mixers, and on-road mobile cranes). Submit pictures showing hydraulics, lifts, motors etc. as needed for verification. Trucks that receive a PTO exemption must be attached to a trailer that needs the PTO to load or unload.

**CERTIFICATION**

Beginning January 1, 2011, all vehicles, including vehicles receiving exemptions under the Drayage Truck Regulation, are subject to the requirements of the In-Use On-Road Diesel Vehicles Regulation, Cal. Code Regs., 2025(e) through (g), as well as the requirements of the drayage truck regulation.
