Community Air Protection Program Technical Summits

February 2018

The California Air Resources Board (CARB) invites you to participate in technical summits on the implementation of the Community Air Protection Program (Program).

The Program was established as directed in Assembly Bill (AB) 617 (C.Garcia, Chapter 136, Statutes of 2017) and provides a new community-focused action framework to reduce exposure in disadvantaged communities most impacted by air pollution. The bill recognizes that while California has seen tremendous improvement in air quality, some communities still suffer greater impacts than others. It is these communities that require special attention and accelerated action. AB 617 builds on the foundation of existing air quality legislation and programs by providing additional tools to target actions in communities that bear the greatest burdens. Over the next several years, CARB and air districts will be working closely with community groups, community members, environmental organizations, and regulated industry to reduce harmful air emissions and create a new framework for community protection.

AB 617 specifically sets out a planning framework for the Program that includes requirements for both CARB and the air districts, including a statewide monitoring plan and community-level air quality monitoring, a statewide strategy and community specific emission reduction programs (Action Plans), among other programmatic elements. AB 617 includes near-term deadlines to ensure expeditious action to reduce exposure to criteria pollutants and air toxics. By October 1, 2018, CARB must work with stakeholders to prepare a statewide monitoring plan and statewide strategy, as well as identify the most impacted communities for deployment of community air monitoring campaigns and/or development of Action Plans.

Staff are drafting a concept paper that provides staff's initial concepts for these elements. Development of the Program is still in the early stages, and the concept paper provides an additional mechanism to seek continued advice and feedback to guide our efforts going forward. The summits will provide stakeholders with the opportunity to have a detailed discussion about the draft concept paper.
