NOTICE OF PUBLIC WORKSHOP – UPDATE

Public Workshop to Discuss the California Air Resources Board's Review of the San Joaquin Valley Air Pollution Control District Emission Reduction Credit Program

The California Air Resources Board (CARB) staff invites you to participate in a public workshop on June 9, 2020 to discuss CARB's review of the San Joaquin Valley Air Pollution Control District's (SJVAPCD) Emission Reduction Credit (ERC) program.

This will be a remote-only meeting.

In accordance with Governor Newsom's Executive Orders <u>N-29-20</u> and <u>N-33-20</u> as well as recommendations from the California Department of Public Health, the workshop will not have a physical location.

CARB will conduct this workshop via Zoom, a web-based videoconferencing platform, and webcast the workshop. Spanish translation services will be provided. During the workshop, public participants will be able to ask questions, provide comments and otherwise fully participate in the workshop. For the past year, CARB staff has been conducting a review of the SJVAPCD ERC system, including the Federal offset equivalency determination, and working to explain this system in the context of the broader District program for reducing emissions from stationary sources including New Source Review (NSR), permitting, and regulatory requirements. This is the third public workshop on this topic. In this meeting, CARB will discuss staff's findings and recommendations, answer any questions that may arise, and receive comments regarding this review from the public. This workshop is being held in advance of the June 25-26 CARB Board meeting, where this topic will be formally discussed.
