## **Asbestos Facts**

Asbestos is not going away

 Asbestos has been proven to be a Scientifically Proven Carcinogen that is hazardous to human health

 Asbestos "Legacy Materials" is still present in thousands of buildings and other structures throughout the United States.

#### **Asbestos Facts**

- Asbestos is a nightmare for workers, companies and the legal system.
- First asbestos lawsuit was filed against a company in 1929.
- Asbestos is one of the largest volume of litigated lawsuit in the United States.
- Over the last four decades, billions of dollars have been awarded in judgments and more than 100 companies have filed for bankruptcy.

#### **Asbestos Facts**

• The State of California has the highest number of mesothelioma deaths in the US.

• From 1999 to 2015 – 4,295 California residents died from mesothelioma.

• Yuba and Siskiyou counties were ranked in the top 50 counties in the US with the highest mesothelioma death rates.























#### **Enforcement Fact Patterns**

 Now with significant budget cuts for both EPA's criminal and civil enforcement programs, States and Air Districts are being deferred to lead anti-pollution prosecutions, even while urging cuts in EPA grants supporting these State and Air District enforcement programs

MicroPHAZIR AS "Nuts and Bolts"

- Uses a Tungsten bulb to that shines infrared light on suspect asbestos containing material and then measures the spectrum of reflective light
- Uses a long lasting lithium ion battery good for 8 hours
- Device stores the data collected which can be downloaded for use

MicroPHAZIR AS - Pros

- Excellent screening tool during asbestos investigations and inspections
- Reduction in evidence sampling and sampling cost savings.
- Relatively ease of use "Point and Shoot" can read through clear sampling bags



MicroPHAZIR AS - Cons

- A 10 minute calibration cycle at start up
- Screens and only identifies the asbestos in the subject material with the greatest percentage content –
- Less accurate on dark materials that don't reflect light (example: mastics)

MicroPHAZIR AS - Cons

 Does not give approximate percentage of asbestos content. Only if asbestos is present/absent.

• Must analyze the actual substrate of a suspect building material – can't analyze through paint layers.

### MBARD NESHAP ASBESTOS

- If possible Having Dedicated Staff for the Asbestos Program Partner Up! (Photograph, evidence gathering, interviewing)
- Every notification/asbestos survey submitted is reviewed for inaccuracies.
- Consistent participation on Environmental Task Force
- Work with sister agencies: Building Departments, Cal/OSHA, Contractor State Licensing Board, Environmental Health Departments, District Attorney Offices
- Work with fellow Air Districts and CARB (NESHAP Group)

























### Potential Violations (NESHAP and Other)

- Inspections/Investigations can reveal NESHAP violations including failing to Thoroughly Inspect for asbestos, Failure to notify, Improper removal, Improper disposal, inadequate wetting, competent person
- Business & Profession Codes for unfair business practices
- Cal/OSHA worker protection, work practices, etc.
- Building Departments for construction without permits or inspection for verification of work with respect to building codes.



## Peel Back the Onion Skin Layers

- Inspections/Investigations can also reveal:
- No state contractor license
- No asbestos abatement license
- No workers compensation insurance
- Building Permit Fraud
- Work Contract Fraud
- Real Estate Fraud
- Fake/Altered Asbestos Surveys/Sampling
- Major Violations = Case submitted to D.A.
- WORK WITH YOUR DISTRICT ATTORNEY!!!!!
