The California Air Resources Board (CARB) invites you to participate in a public workshop to begin discussion of a regulatory measure to accelerate the deployment of zero-emission ground support equipment (GSE) at airports. This workshop initiates CARB's effort to develop measures to increase the adoption of zero-emission technology in the off-road sector.

### **Meeting Information**

At this workshop, staff will be soliciting input from stakeholders and industry on regulatory approaches to accelerate the transition of diesel and large-spark ignition airport GSE to zero-emission technology. Additionally, topics for discussion at the workshop include the scope of the proposed regulation, coordination with existing in-use fleet regulations and the role that incentives or voluntary agreements may play in enabling this effort.

## **Background**

Mobile sources, including off-road equipment and the fossil fuels that power them, are the largest contributors to the formation of ozone, PM2.5, diesel particulate matter, and greenhouse gas (GHG) emissions in California. Promoting the development and use of zero-emission ground support equipment will help CARB achieve the emission reduction strategies outlined in the Mobile Source Strategy, State Implementation Plan, and the Sustainable Freight Action Plan. Airport GSE operate at airports and perform a wide variety of functions including providing power to aircraft, transporting cargo, baggage, and passengers to and from aircraft, and providing aircraft maintenance and fueling. This measure will act as a catalyst to further adoption of zero-emission equipment in the off-road sector, facilitate the transfer of technology to suitable heavier duty-cycle applications, and expand use of zero-emission infrastructure.

The overall goals of this effort are to:

- Complement existing programs to achieve oxides of nitrogen (NOx) and GHG emission reductions through the use of zero-emission technology.
- Support the near-term deployment of additional zero-emission ground support equipment in applications where well-suited to its use.
- Increase the penetration of zero-emission off-road technology in applications that are economically feasible.
