DOCUMENTATION

Your entity is responsible for managing the cap-and-trade compliance obligations for the facility or facilities associated with your entity account in the Compliance Instrument Tracking System Service (CITSS). This form may be used to document changes in existing facility information, or a new facility entered into CITSS.

This form may be used to:

- Document information updates for a facility that is already in CITSS, or
- Document the addition of a facility into CITSS that has never been registered to CITSS.

An entity's Primary Account Representative (PAR) or Alternate Account Representative (AAR) must submit these changes in CITSS for Jurisdiction Registrar approval. This completed form, along with completed attestations and signatures, may be submitted to the California Air Resources Board (CARB) Registrar at CACITSSRegistrar@arb.ca.gov for approval before the proposed changes in CITSS can become effective. You may also choose to include the completed facility information page from CITSS and attach the attestations page from this form. If you are entering information for more than one facility, provide a completed Facility Information page for each facility.

The last page of this form provides the required attestations that must be signed by an entity's representative (PAR or AAR) and an authorized Director or Officer who has been disclosed to CARB.

EXISTING REGISTERED CITSS FACILITY

An account representative (PAR or AAR) can revise information about a facility already associated with the entity account by selecting the "Edit Facility" button at the bottom of the Facility Information page in CITSS. Most changes to facility information do not require documentation for Registrar approval. For example, changes to the Facility Legal Name or Operating Name requires Registrar approval and submission of a signed attestation from an active CITSS account representative pursuant to section 95832(d) of the Cap-and-Trade Regulation (Regulation; title 17, California Code of Regulations, sections 95800 et seq.).

ADDITION OF A NEW FACILITY

A new facility is a covered facility or emissions source that is assigned a Greenhouse Gas Reporting ID Number from CARB's Mandatory Reporting Program, and is already owned or operated by a registered entity but has never been registered in CITSS. The request to add a new facility in CITSS will require the authorization of an authorized director or officer already disclosed pursuant to section 95830(c) of the Regulation.

NOTE: Do not use this form if your entity has purchased a covered facility or covered emissions source. Instead, refer to the <u>Change of Ownership Form</u> provided by CARB. Changes in facility ownership require coordination between the selling and purchasing entities, requesting administrative transfer of compliance instruments between entity accounts, and disclosing updates to changes in corporate associations and structure. This form does not provide adequate documentation of a facility change in ownership as described pursuant to section 95835 of the Regulation.

If your entity has purchased a covered facility, refer to the <u>Change of Ownership Form</u> provided by CARB. Changes in facility ownership require coordination between the selling and purchasing entities, requesting administrative transfer of compliance instruments between entity accounts, and disclosing updates to changes in corporate associations and structure.
