#### **One-Time Reporting Requirement**

- Larger entities that operate a facility in California
  - Public, private and other organizations with at least one vehicle
- Vehicles with a gross vehicle weight rating >8,500 lbs
  - Excludes cars and light-duty SUVs and pickup trucks
- Affected vehicle owners must report no later than April 1, 2021



## One-Time Reporting Requirement (Cont.)

- Records must be kept until December 31, 2024
- Affected vehicles owners who do not report by the deadline will be subject to enforcement action and penalty
- Does not change any other reporting requirements



#### Who Must Report

- Organizations with more than \$50 million in revenues
  - from all related subsidiaries, subdivisions, or branches, and has at least one vehicle with a gross vehicle weight rating (GVWR) greater than 8,500 lbs.; or
- Owns 50 or more vehicles (with GVWR greater than 8,500 lbs.); or
- Dispatches 50 or more vehicles (with GVWR greater than 8,500 lbs.) into or throughout California; or
- Government agency (federal, state, local, and municipalities) and has at least one vehicle with a GVWR greater than 8,500 lbs.



# Reporting Excludes the Following

- K-12 schools, school districts, primarily school bus fleets
- Transit vehicles subject to the Innovative Clean Transit regulation
- Military tactical vehicles as described in <u>13 CCR 1905</u> and military tactical facilities
- Vehicles awaiting sale; or
- Emergency vehicles per <u>California Vehicle Code Section</u> <u>165</u>.



# Preliminary Draft Reporting Guide

- Describe reporting require reporting requirements
- Additional guidance on select questions
- Three primary survey sections
  - General entity information
  - Home-base location
  - Vehicle operation
- Companion to spreadsheet questionnaire



#### Process to Save and Upload Survey Responses

- Download Excel spreadsheet from CARB website
  - Respond to survey questions
  - Built-in menu choices and basic validation
  - Save on own your own disk drive until completed
  - Export completed survey to a data file
- Upload completed data file on CARB website
- Seeking volunteers to beta test



#### **Outreach and Education Overview**

- Partner with associations
  - Provide content for news letters and member bulletins
  - Coordinate reporting information
- Direct physical and electronic mailers to affected organizations
- Online guide and factsheets
- Press releases
- Training classes (live/recorded)
- Hotline assistance



#### Next Steps on One-time Reporting

- Finalize the one-time reporting guide
- Update the spreadsheet reporting form
- Beta test upload process
- Prepare outreach materials
- Make available for use before the end of 2020



#### Proposed Advanced Clean Fleets Regulation

- Zero-Emission truck and bus fleet by 2045 everywhere feasible
  - Earlier transition for certain market segments
  - Initial focus on larger fleets and large entities that hire them



# Proposed Advanced Clean Fleets Regulation (Cont.)

- Scope includes wide range of stakeholders
  - Owners of vehicles with a GVWR >8,500 lb (or Class 2b and up)
  - Other entities that hire truck and bus fleets
  - Government, private business, and others
- Build on other supporting zero-emission vehicle policies



# Principles for Developing ZE Fleet Rules

- Maximize ZEVs deployed to meet air quality and GHG goals
- Focused action in disadvantaged communities
- Simple and streamlined compliance and enforcement
- Match vehicle capabilities with fleet operational needs
- Expand infrastructure access to enable new markets
- Include smaller vehicles where appropriate
- Ensure level playing field



## **Rulemaking Overview**

- Initial focus on truck types and use cases that are most suitable
- Target largest fleets and business for early deployment
  Own and hired vehicles
- Enable full transition with secondary market
- Align with ACT manufacturer ZEV sales requirements



## Rulemaking Overview (Cont.)

- Maximize ZE technologies where feasible
  - Encourage NZEVs and other innovative technologies
- Consider appropriate framework for different fleets or situations
- One rulemaking phased in 2023 to 2045
