

Compliance Instrument Tracking System Service Registrants Report March 28, 2014

If a voluntary entity is an individual, the individual’s name is listed as the “Legal Name.” The “Entity ID” is the unique identification number for each entity. “Entity Type” is the status of the entity as a covered entity or voluntary (general) participant in the Cap-and-Trade Program. “Mandatory Reporting GHG ID(s)” is the reporting ID of the facilities subject to the Mandatory Greenhouse Gas Reporting Regulation that are associated with the entity. This list contains entities registered in CITSS pursuant to California’s Cap-and-Trade Regulation and does not include entities registered in a linked jurisdiction’s program.
