Dear Ms. Juarez

The California Air Pollution Control Officers Association (CAPCOA) has advocated for a statewide woodstove replacement program funded by California Greenhouse Gas Reduction Funding. These Cap and Trade Grant funds along with the AB 617 Community Air Protection grant have provided Siskiyou County Air Pollution Control District to develop a woodsmoke reduction program.

The District has had an over whelming response from residents to replace old heating devices with new EPA certified woodstoves. District has allocated the AB 617 Community Air Protection funding to the Woodsmoke reduction program to fund those additional heating devices in low income communities.

- II. **Report costs associated with specific tasks:** Implementing our woodsmoke reduction program we reach out to low income areas that had applied for our WRP. These are strategic areas impacted by wood burning smoke during winter inversions. We trained additional staff of how to implement the guidelines in Siskiyou County. Added additional retail dealers in the surrounding area; cost of staff time, contact and collaboration with building departments regarding the program; cost of staff time.
- III. **How is grant being utilized:** funding new EPA certified heating devices in Low Income communities
 - a. Upgrade 5 uncertified woodstoves burning 20 cords of wood annually –changed out to an EPA certified woodstove or wood insert. The new devices efficiency range from 72% to 79%.

- IV. **Summary of work completed:** we have completed 5 EPA certified heating device upgrades in AB 1550 Low-income Communities. This is our first progress report for this funding.
