Amador Air District (AAD) provides free disposal of green waste for all County residents. We work with ACES Waste Services (local waste company) to coordinate these efforts. Our program branches out into three different sections: during May through October (once a month) free green waste disposal days at the upcountry transfer station, a bin at a local Fire Station available year-round for green waste and rotation of neighborhoods in the most needed areas that receive a bin for two weeks at a time for their green waste clean up.

III. How is grant being utilized to meet goals of AB 617:
(If applicable, include emissions reductions being achieved)

The Smoke Reduction Bin Program was started by the AAD in an effort to reduce outdoor burning and minimize smoke in Amador County. Providing cleaner air and helping communities reduce emissions. This program allows us to recycle during the year more than 500 tons of green waste that would have been burned if our program didn't exist.

IV. Summary of work completed and in progress since the last progress report:

Our Smoke Reduction Bin Program offers free disposal of green waste to minimize burning within the County. AAD hosted free green waste disposal once a month for six months for all residents in the County. In addition, we also have a 40-yard bin at one of the local fire stations (year round) for free disposal of green waste and our Neighborhood Green Waste Program, which provides a 40-yard bin in different neighborhoods throughout the County for green waste, for two weeks at a time. All minimizing the amount of burning and smoke.
