- Signed Clean Vehicle Grant Confirmation (signed by both the dealer and the customer)

2. Used Vehicle Requirements:

- Vehicle history report
- Proof of mechanic inspection (including documentation of no recalls or that open recalls were fixed. Recall information found here: <https://www.nhtsa.gov/recalls> )
