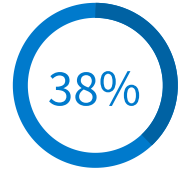

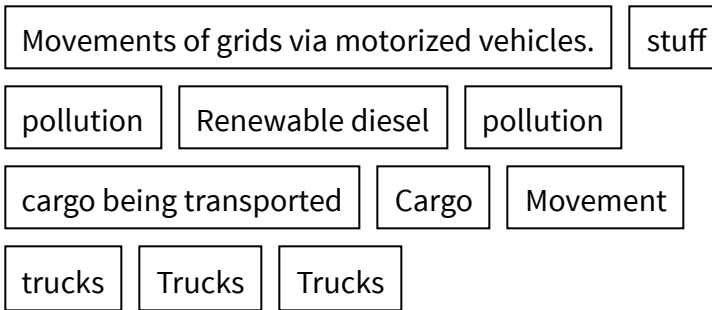

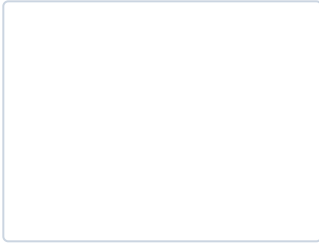

- WAY TOO MANY!

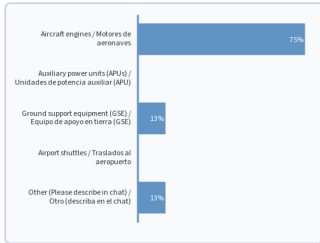

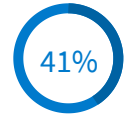

- Have workshops and mini groups

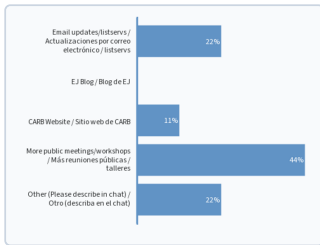

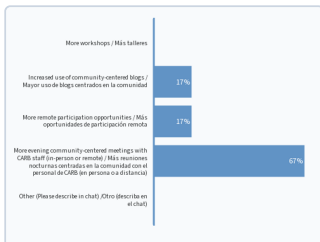
