## Consultation Group Purpose Discussion

Michael Jerrett

• It is hard to make recommendations without concrete numbers about funding

Ms. Margaret Gordon

- Are you asking about budgets for convening or budgets for AB617 program?
- Requested standing budget item for CG meetings
- And included in the convening

Martha Dina Arguello

• We need to have a say in how funds are allocated and having the budget being a standing item feels right.

Jana Ganion

- Interested in statewide mandates, enforcement, and emission reduction metrics, especially for communities that have not been selected
- The supporters of this bill need to see that it is being effective

Janet Whittick

• Wants to talk about these things in the CG: metrics, BARCT, statewide strategy, criteria and toxics reporting

Jesse Marquez

• Mentioned importance of a UFP standard and need for health studies and support for health impact assessment process. Gave example of Port of Long Beach scoping report for an HIA

Deldi Reyes

- Let's get back on the agenda and discuss purpose of CG
- At last meeting heard your comments and reactions to the language from the draft charter, i.e., "guide is not strong enough"
- CARB cannot "cede" authority to others, and neither can ADs purpose of group is to guide

Kevin Hamilton

- We are a consultation group, but what form and who are we consulting with?
- Should be consulting with our constituencies

- Also consulting with agencies
- Need more structure

Ms. Margaret Gordon

- We've never had a listening session from the AB617 CG members that are part of a selected AB 617community, framed into an agenda.
- Audience would be agency staff who are not aware of conflicts, so that staff could be more effective and engaged in problem solving

Luis Olmedo

- There are a lot of CARB staff that show up, and it is not clear how it is helping this process
- Show up and help, or don't show up, and push money to consultants instead
- Community questions are not answered
- Are the dollars being spent in effective manner
- CARB should provide technical support or revisit budgets, or use that money for outside consultants

Martha Dina Arguello

- This is an important group
- Co-lead model is good, but find roadblocks with Air District
- More participatory budgeting
- More experts, but ADs should supply data as needed
- The model is clunky

**Deidre Sanders** 

• This group could be more like a <u>NEJAC</u> listening session where community members speak, and the CG listens

Ms. Margaret Gordon

- No support to build community engagement capacity
- Need uniformity across communities and agencies
- CARB staff are at meetings, but there is no exchange between CARB staff and CSC members
- Where are the convening consultation group

Kevin Hamilton

• Wants to hear from Samir and Wayne

Wayne Nastri

• Funding issues and stressful environment

- Agrees with CG statements
- Agrees with Wayne

## Dr. Balmes

- In support of Kevin's point, "If the CG is going to realize it huge potential, it has to be a safe space for EVERYONE to bring their perspectives and information."
- AB617 implementation needs equity and EJ focus
- CARB initially envisioned the Consultation Group as a forum and safe space for stakeholders (communities, air districts, business) to share their perspectives
- Need to be able to navigate areas of disagreement to move forward.
- Uplift EJ but Districts/CARB/business should be able to be heard

- What will help you moving forward (CG)

# Luis Olmedo

- ADs can be unresponsive and that can create tension
- All adults in room, need to be open in conversations

# Gustavo Aguirre Jr.

- Found the CG to be a good information exchange mechanism
- Perception that residents will have the lead in this program
- ADs still seem to lean on existing structures
- Not a lot of creativity in the program design
- What can everyone do to move the process forward
- Ex: existing use of the nut harvesters as an effective mechanism, but what else can we do?

# Jesse Marquez

• Needs CARB to intervene and confirm that AB 617 is being implemented legally

# Ms. Margaret Gordon

- Points to comments in chat from Martha Dina and Vincent
  - Vince: One idea was to hire the community members to do the work of outreach and surveys. There is an opportunity to connect to the community

with who they know and trust. Some of the Air District and CARB personnel are not the right people to reach the community especially if there is no time at our meetings for real public input.

- Martha Dina Arguello: What is see over time is that we are saying and asking for the same thing--transparency, participatory budgeting, addressing the past harms like the Sacramento folks being kicked off the committee and increasing the opportunity to learn from other communities. Make some legislative fixes to the time-lines and focus on health metrics.
- Agency staff need to be brought into the process with community orientation
- Community surveys and outreach
- Budget transparency at the state and AD level.
- What is CARB's authority over the ADs?

- No point to have another meeting where we just complain to each other
- Need to get things down paper, and find a way to track progress
