Key Outcomes

Priority Topics for Sept 21

Not a heavy agenda – place priority items first

- Brief CG Process discussion: ask group for ways we can hear from everyone
- CG Purpose (2 votes)
 - Process recommendations for this agenda item:
 - Veronica: Structure discussion carefully, provide straw proposals for the group to react to, and envision the group's likely end products, to help the group have a productive discussion and reach shared agreement.

- Background/orientation re CG and role in 617 introduce via history, invite Richard, Chanell present; share running list
- Request Richard/Chanell in the room for discussion
- Notes:
 - (KH) To show value, Richard EO/Board proclamation stating what CG is/does/role/responsibilities
 - CARB seems to see it as an ad hoc committee, does not value it. (MG, KH)
 - Veronica: Original role: vehicle for CARB to engage all listed groups in 617 + academics/scientists. Now time to revisit. Specific questions were brought to CG, wasn't best agenda-consultation process more work needed to capture EJ/community topics/questions.
 - Straw proposals for Purpose:
 - (KH): oversight/advisory to CARB on AB 617 implementation at multiple levels from the CSCs to policy development around air toxics, BACT/BARCT, on <u>all</u> 5 pieces of the CAPP.
 - (MK) 1) identify needs to be done at state level 2) what happening at local 3) how effective 4) how to improve
 - Includes CG serving as advisor to CSCs
- Review topics to date & seek to prioritize
 - Suggestion that each interest caucus identify its priority topics (this could help to balance agendas for all interests)
- Budgeting: where are gaps in participatory budgeting process now? (1 vote)
- People's Blueprint status & timing when good for a CG meeting? (timing not yet clear)

Consultation Group Process – How to Improve

Goals:

- More productive meetings
 - How to shape and move items forward
- Create space for free & hearty debate among all stakeholders, including those now quiet
 - o How can we create space to hear from everybody? How to support people to feel comfortable sharing?

Recommendations

Productivity:

- Produce flowchart of org and how stakeholders interact with it
- Group needs to prioritize all the ideas in a simple document key new CG tool
- Each caucus has their topics industry, AD, (OPR), EJ in agenda-setting
 - o Those reps produce more clarified agenda items
- Facilitator work more actively to curb circular discussions, keep people on topic, create room for other voices (people who wax long know that they do)

Inclusivity in discussions:

- ADs, CAPCOA, industry Ask specific individuals/interests to speak
- Industry wants to share CG/CSCs invite them in re specific issues communities may have: their intent, process, efforts to educate themselves on EJ/equity. How happen in way acceptable for EJ? Public comment not the best place. ✓
- Industry asked to speak on topics relevant to CG, such as regulation, CG concerns, etc.
- CG can task industry to poll their members on key issues ✓
- Best for CG member industry reps to present/represent those issues
- Groups who may feel disenfranchised give more public time, or written comments collected/discussed/categorized/out on table
- Engage/draw people out with clarifying questions: what do you mean by this?
