Since entering into the AB 617 grant agreement with CARB, the District has iii. developed a Best Available Retrofit Control Technology (BARCT) Implementation Schedule. The implementation schedule was presented to the public at a public workshop on January 22, 2019. The Implementation Schedule was presented to the public and the Air Pollution Control board on May 7, 2020, and approved on the same day. Since this time the District has begun research and engineering calculations into implementation of the BARCT requirements for its two applicable facilities. This work is nearly complete and will continue beyond the performance period.

iv. The Shasta County AQMD is currently working with the two sources of air pollution that are subject to BARCT implementation. Facility #1 is subject to an EPA NOx emissions consent decree. The District's draft evaluation document proposes this emission limit as BARCT for the facility.

Facility #2 is a relatively unique industrial process requiring significant evaluation of options for control of nitrogen oxides. District staff have spent considerable time identifying control technologies and related emission limits. The District is currently near completion of this process and will incorporate this determination into the rulemaking process that is currently underway. Per the BARCT Implementation Plan, the District is conducting BARCT rulemaking as scheduled and should have a rule adopted in 2021.
