2022 Scoping Plan development schedule

 Comments for the Draft 2022 Scoping Plan Update must be received no later than June 24, 2022

June 23rd -24th Board Meeting

- If EJAC would like to present at the board meeting, CARB needs to know at least 10 days in advance of the board meeting, and needs all presentation materials at least 3 days in advance of the board meeting
- Next proposed EJAC meeting on June 22nd



Incorporation of EJ Advisory Committee Recommendations

- The EJAC met over dozen times since early last summer to help inform this Draft 2022 Scoping Plan
- Developed over 200 recommendations
- Incorporation of feedback into the Draft 2022 Scoping Plan Document
 - Modeling input incorporated into the design of the scenarios
 - Additional evaluation of phasing out refinery operations by 2045
 - 5 dozen references to EJAC Draft Recommendations in the Draft Scoping Plan
 - Categorizes recommendations that could not be incorporated into the Draft Scoping Plan as well as a process for following up



Draft Scoping Plan Communication Strategy

- Hosted media briefing on May 10th and circulated press release on draft Scoping Plan.
- Draft plan was circled and/or covered via Twitter, print and online news articles, television news and radio.
- Over the summer, CARB will host workshops and community listening sessions to hear from communities across the state and share what the Scoping Plan is and its role to address climate change.



Governor's Budget Process Update

- <u>May Revision of the Governor's Budget</u> released on May 13, 2022
- Almost all budget items of interest will go through <u>Assembly Budget Subcommittee No. 3</u> and <u>Senate</u> <u>Budget Subcommittee No. 2</u>. You can use the "Subscribe to Stay Connected" links to sign up for email alerts when agendas are posted, which typically only happens one or two days in advance of a hearing.



Governor's Budget Process Update

 The agendas will include the staff recommendation (e.g., support as budgeted, reject, or hold open are the most common recommendations). Public comment is always at the end of the hearing and encompasses all items.



Governor's Budget Process Update

 The Subcommittee webpage will include call-in information about how you can provide public comment on the day of the hearing. Public comment is how you can let the Subcommittees know which items you support and which you oppose. After the budget subcommittee process is over (typically mid-May), the full Budget Committees of both Houses will go through the same process.



CARB Bilingual Services

- CARB received request to translate Draft Scoping Plan into Spanish and Chinese.
 - CARB staff has completed the language services request form and submitted the request to CARB's Bilingual Services Coordinator.
 - Estimated 4 weeks for Scoping Plan to be interpreted in Spanish and Chinese.
