Section 6: Programmatic Alignment

Our proposed project "Improving Community Indoor Air Quality by Identifying Vapor Intrusion - Expansion" is in selected AB617 "Priority Communities" in Vallejo Identified as SB535 Disadvantaged Communities by OEHHA, and CARE Communities by Bay Area Air Quality Management District. All Positives Possible activities and goals align with AB 617 state mandated programs which requires community-based lead actions/activities that will result in reduction of air pollution and emissions especially in low-income areas disproportionately affected and impacted by air pollution. APP's goals to effectuate changes in our community incorporating environmental justice, community engagement and community led strategies to help improve our quality of life and health using emissions reduction strategies, we believe will meet the AB617 goals. We will utilize and partner with affected residents, tribal partners, consultants, other community-based groups, air, and water agencies, to identify homes in need of air and water filtration systems, install them, gather and research information on the impacts of pollution and toxins to our health, affecting our immediate environment, and work spaces, through collaborative emission reduction strategies, community health monitoring, community engagement, by community led solutions with an environmental justice approach.
