California Air Resources Board (CARB) staff invites you to participate in a public workshop to discuss proposed regulatory amendments to CARB's certification procedures for vapor recovery systems designed for use at gasoline dispensing facilities (gas stations) and gasoline cargo tanks.

State law requires CARB to adopt procedures to certify and test vapor recovery systems or components designed for use at gas stations and on gasoline cargo tanks. Test procedures other than those specified in CARB certification procedures can be used only if prior written approval is obtained from the CARB Executive Officer.

The goal of this workshop is to provide information and solicit input from stakeholders on proposed amendments to CARB certification procedures that include:

- (1) Removal of language that does not provide clear instruction for CARB's Executive Officer to approve alternative test procedures as described in the following sections of the certification procedures:
 - Section 14.4 of CP-201: Certification Procedure for Vapor Recovery Systems at Gasoline Dispensing Facilities Using Underground Storage Tanks;
 - Section 5.4 of CP-204: Certification Procedure for Vapor Recovery Systems of Cargo Tanks;
 - Section 15.4 of CP-206: Certification Procedure for Vapor Recovery Systems at Gasoline Dispensing Facilities Using Aboveground Storage Tanks; and
 - Section 8.4. of CP-207: Certification Procedure for Enhanced Conventional (ECO) Nozzles and Low Permeation Conventional Hoses for Use at Gasoline Dispensing Facilities
- (2) Various non-substantive edits to document formatting (use of upper case and bold text emphasis, new font, font size, and the use of "styles") to comply with updated CARB and Americans with Disability Act (ADA) accessibility requirements for documents made available to the public.

The workshop will include a brief presentation describing CARB staff's proposal, followed by a question-and-answer session. During the workshop, remote attendees can submit comments or questions either through the Zoom chat feature or via email to *vapor@arb.ca.gov*.

Prior to the workshop, CARB staff will post electronic copies of the draft regulatory text (underlined text to indicate additions, strike-through text to indicate deletions) and the workshop presentation on CARB's vapor recovery program website at https://ww2.arb.ca.gov/resources/documents/preliminary-rulemaking-activity-0.
