

Commercial Smoke Tester Courtesy List

This list is provided as a courtesy. Smoke test technicians must hold a current certificate issued by the California Council on Diesel Education and Technology (CCDET) in the technician's name and the test strip must list that certificate number along with the technician's full name and signature.

Note that a new regulation, the Heavy-Duty Inspection and Maintenance Program (Heavy-duty I/M), will incorporate the Periodic Smoke Inspection Program (PSIP) beginning January 1, 2023. Heavy-duty I/M is a smog check program for heavy-duty trucks where owners of most non-gasoline powered trucks over 14,000 pounds Gross Vehicle Weight Rating (GVWR) that operate in California will have to perform periodic inspections to ensure that their trucks are operating as intended. Phased in implementation begins 1/1/2023 with periodic testing beginning in 2024. Until periodic testing begins, truck owners will still need to complete PSIP testing and keep the records as specified in the PSIP regulation.
