



Foundation: People's Blueprint

- Equity-centered approach to pursue just implementation of the Community Air Protection Program
- Root BP 2.0 in environmental justice (EJ)
- Highlight lessons learned from a community-based and EJ perspective
- Key Themes and Concepts:
 - Operationalize equity and EJ
 - Participatory budgeting
 - Community readiness to engage in the program
 - Building technical capacity
 - Building agency capacity

- Models of partnership and co-leadership
- Meaningful engagement
- Guidance on steering committee membership
- CSC governance including charters and conflict resolution
- Tracking results to support effective implementation and accountability

Defining the Problem

- Communities near ports, rail yards, warehouses, and freeways that experience a higher air pollution concentration from mobile source emissions from cars, trucks, locomotives, and ships.
- Pollution impacts from
 - Large industrial facilities such as oil refineries
 - Cumulative impacts of smaller, but more numerous industrial facilities
 - In rural communities from pesticides, oil and gas development, and agricultural activities.
- Racial and ethnic disparities in air pollution burden and vulnerability we see today are the result of structural racism.


Community Emission Reduction Programs

CSC Governance







- Streamlined and accessible annual reporting
- Reporting until all CERP actions are complete
- Fifth Year Annual Report

Consistently Nominated Communities

- Engagement with 65-plus communities
- Three pathways:

Flexibility in Incentives ~\$195M - \$250M

Community Air Grants ~\$10M

Consistently Nominated Communities

New Statewide Incentive Strategies

- Districts and CSCs have created dozens of new incentive projects since 2019 that we now propose statewide
- Expand Chapter 5 to focus on all sensitive receptor locations

New incentive chapters for...



- Agency Partnership Projects
- Dial-A-Ride Vehicle Replacement



 Vegetative Barriers and Urban Greening

- Emergency Diesel Generator Replacement
- Paving, Sidewalk, and Bike Path Projects



Community-Focused Enforcement

- Working closely with community to understand enforcement-related air pollution issues not being addressed
- CARB Enforcement staff concentrates investigations and enforcement in areas identified by the community, some of which we traditionally do not enforce
- Community priorities are central in developing and implementing enforcement plans
- Can be used in
 - Selected communities
 - Community-led projects supported by a CAG
 - Other community-led partnership


Community Air Grants

- Purpose: Technical assistance funding to community based non-profit organizations and California tribal governments
- In the Draft Blueprint 2.0, a new CAG project type - Local CERP - will support community-led projects in prioritizing, planning, and implementation

- Public process to refine the next cycle of CAG Request for Applications


