


DEADLINE FOR CONCEPT PHASE APPLICATIONS IS SEPTEMBER 8, 2023

Planning and Capacity Building (Planning), Clean Mobility in Schools (CMIS), and the Sustainable Transportation Equity Project (STEP) Request for Applications (RFA) aim to increase transportation equity by identifying and addressing communities' transportation needs, increasing access to key destinations and services, and reducing greenhouse gas emissions and vehicle miles traveled.

CMIS and STEP grant

\$29.65 million available for 2 to 4 grants with projects such as:

	Active transportation (bicycle and pedestrian infrastructure, multi-use paths, safety improvements)
essments	Zero-emission fixed-route transit and school bus service (service improvements, expansion, rider subsidies)
	Zero-emission shared mobility (carshare, rideshare, vanpooling, carpooling, bikeshare, scooter-share, ride-hailing, shuttles, and microtransit)

Steps to Apply

1	Sign up to receive technical assistance by August 11, 2023.	
2	Review the Planning, CMIS, and STEP eligibility requirements and select the grant you want to apply to.

3	3 Identify projects, partners, and roles to implement the projects.	
4	Work with the technical assistance provider to create a Project Community map.	
5	Complete the Concept Phase application.

6	Submit the Concept Phase application and map to step@arb.ca.gov by September 8, 2023.	
7	CARB scores the Concept Phase application and posts the results online.	
If your application meets eligibility requirements and scores at least 70%: If your application does not meet eligibility requirements or scores below 70%:		
8a	Receive CARB notification and apply to Full Phase, deadline: November 3, 2023. Bb Receive CARB notification and attend a debrief with CARB staff.
