Particulate Matter (PM) Emission reductions from open burning are achieved through the program.

Provided roll offs dumpsters for green waste disposal in 4 communities in Lasssen County. Over 103 Tons of green waste was collected. Estimated PM Reduction of 0.4148 Ton at a Cost Effectivness of \$26,880.75/Ton.
