Report on how grant is being used by the District:

The grant funding is being used to implement the Community Air Protection Program in San Diego County (CAPP) pursuant to AB 617 (2017 Statutes). Activities to date have focused on the Portside Environmental Justice Neighborhoods, with some additional work conducted in the region's other State-identified disadvantaged communities, such as the San Diego International Border Community (IBC). Staff priorities have been established to facilitate compliance with the requirements and timelines in AB 617. Significant resources have been expended to conduct extensive community outreach and to establish a CSC for the IBC. A monitoring plan is being implemented for the Portside Community and one is under development for IBC. The Portside Community Emission Reduction Plan (CERP) is was approved by CARB and is now being implemented. Other work has included conducting increased inspections, reviewing regulations, and implementing the Portside CERP.

Summary of work completed:

- Portside Community Steering Committee (CSC) meetings have been conducted online monthly
 from 5 to 7 p.m. with participation of community residents, community-based organizations,
 industry groups and industry members, local jurisdictions, and planning agencies. Meetings
 have included simultaneous interpretation services in English/Spanish and are led by a
 professional facilitator who works with APCD staff and the CSC on developing agendas and
 preparing presentation materials and meeting notes.
- APCD brought onboard an Outreach Coordinator who has been engaged in the CSC and has
 worked to make information more accessible to the public and members of the community.
- Staff has been working with community members, the CSC, and partner organizations to implement the CERP.
- Staff has organized and led multiple meetings with agencies that have an implementing role to coordinate on deliverables for the CERP and track progress.

- Staff worked on amending District Rule 1210 (Toxic Air Contaminant Public Health Risks—Public Notification & Risk Reduction) which reduced the health risk threshold for cancer from 100-in-one-million to 10-in-one-million for facilities to take action.
- Staff is analyzing a number of rules that would benefit the community and that were identified by the community as priority for the CERP, including a potential Indirect Source Rule.
- Staff has worked on the development of the Portside Air Improvement and Relief (PAIR) Program, which provides new portable air purifiers and indoor air monitoring systems to selected residences in the Portside area, at no cost to participants. A contract was established with a third party to administer the daily operations of this program
- Participated in CARB-District working groups on various requirements of AB 617.
- Established a CSC for the recently selected San Diego International Border Community (IBC).
- IBC CSC meetings have been conducted online monthly since March of 2022 from 5 to 7 p.m. with participation of community residents, community-based organizations, industry groups and industry members, local jurisdictions, and planning agencies. Meetings have included simultaneous interpretation services in English/Spanish and are led by SDAPCD staff who works with APCD staff and the CSC on developing agendas and preparing presentation materials and meeting notes. A professional facilitator will be hired in the coming months following the model of the Portside CSC.
- Staff continues to implement the Portside Community Air Monitoring Plan (CAMP) by collecting and analyzing data from five monitoring sites in the community and working on setting up additional sites, contacting property owners, developing contracts, and submitting work requests to San Diego Gas and Electric.
- Staff is collecting and analyzing data from two additional sites in support of air quality monitoring efforts in the Border Community and is actively working on the development of the CAMP for IBC.
- Participated in biweekly phone calls with CARB staff where updates and issues were discussed.
