At the workshop, staff will summarize the proposed updates of methodologies and data to the EMFAC202x model. This will be the second public workshop to discuss the major updates to the EMFAC model.

#### Background

The past several decades have seen dramatic improvements in air quality as a result of regulations that reduced emissions from stationary and mobile sources. However, substantial additional emissions reductions are necessary to meet more stringent ozone air

quality standards and California's long-term greenhouse gas emissions reduction goals. CARB is expanding its mobile source analysis tools to support air quality planning focused on achieving these goals.

The EMFAC model is the primary tool that CARB uses to assess emissions from on-road vehicles including cars, trucks, and buses. This will be the second public workshop to discuss the development of the latest version of the EMFAC model, also known as EMFAC202x. At the webinar, staff will provide a description of updates to methodologies and most recent data. A final workshop in late 2020 or early 2021 will cover emission impacts from these updates and explain differences between the new estimates and those from the prior version of the model, EMFAC2017.
