Concept Phase Application Summaries

Posted October 13, 2023

For Fiscal Year 2022-23 funding, the California Air Resources Board (CARB) has \$32.65 million available to fund planning, clean transportation, and supporting projects for multiple grantees across the State. CARB has previously awarded a total of \$77.2 million to these projects. The Request for Applications *for Planning and Capacity Building (Planning), Clean Mobility in Schools (CMIS), and the Sustainable Transportation Equity Project (STEP)* is a two-phase process.

Process and Scoring

The Concept Phase application deadline was September 8, 2023. Staff reviewed eligibility requirements for all Planning, CMIS, and STEP applications. On September 13, 2023, CARB notified Lead Applicants if documentation was missing, or if eligibility requirements could not be confirmed. Applicants that received this communication had until September 15, 2023, to respond with missing documentation. Staff scored all applications that met eligibility requirements. Applicants that scored 70% or higher were invited to apply to the Full Phase.

Concept Phase Applications Received

CARB received 55 Concept Phase applications, requesting a total of \$216,631,766 in CARB funding.

- Planning: 23 applications. Total CARB funding requested: \$9,232,520
- CMIS/STEP: 32 applications. Total CARB funding requested: \$207,399,246

30 Concept Phase applications were invited to the Full Phase. These applications requested a total of \$122,909,790 in CARB funding.

- Planning: 13 applications. Total CARB funding requested: \$5,774,520
- CMIS/STEP: 17 applications. Total CARB funding requested: \$117,135,270
