JUDGMENT FOR PLAINTIFF PEOPLE OF THE STATE OF CALIFORNIA

It appearing that defendant RICARDO MOTORS, LLC, a limited liability company, and defendant RICHARD WANG, aka Kheng Chan Voong, Richard Chan Voong, and Richard Kheng Chan, having been regularly served with process, having failed to appear and answer the plaintiff's complaint filed herein, and the default of this defendant having been duly entered, on application of plaintiff to the court, and after having heard and considered the evidence; and

It further appearing from the Court's file that defendants Tony Wong, Mitchell Wong, Reuben J. Lajda and Hibird USA, LLC, previously entered into a Stipulation for Entry of Judgment and Order Thereof, with plaintiff People of the State of California, ex rel. the State Air Resources Board.

IT IS ORDERED AND ADJUDGED that RICARDO MOTORS, LLC, a limited liability company, and RICHARD WANG, aka Kheng Chan Voong, Richard Chan Voong, and Richard Kheng Chan, are jointly and severally liable to pay penalties in the amount of \$2,550,000 for violations of Health and Safety Code section 43153 as alleged in the First Cause of Action of the complaint. The court suspends imposition of penalties for the violations of Health and Safety Code section 43151 and 43152 as alleged in the First and Second Causes of Action; respectively.

IT IS FURTHER ORDERED AND ADJUDGED that a permanent injunction is hereby issued against RICARDO MOTORS, LLC, a limited liability company in its own name and by any name that it is known to do business and RICHARD WANG, aka Kheng Chan Voong, Richard Chan Voong, and Richard Kheng Chan, as follows:

- 1. RICARDO MOTORS, LLC, a limited liability company, is enjoined from violating Health and Safety Code section 43151, including, but not limited to, importing, delivering, purchasing, receiving, or acquiring new motor vehicles or new motor vehicle engines, including, but not limited to, motorcycles, scooters and all-terrain vehicles for use, registration, or resale in California without obtaining the proper certification from the State Air Resources Board;
- 2. RICARDO MOTORS, LLC, a limited liability company, is enjoined from violating Health and Safety Code section 43152, including, but not limited to, importing, delivering, purchasing, receiving, or acquiring new motor vehicles or new motor vehicle engines, including, but not limited to, motorcycles, scooters and all-terrain vehicles intended for us in

California, for sale in California, or for registration, leasing or rental in California, without obtaining the proper certification from the State Air Resources Board;

- 3. RICARDO MOTORS, LLC, a limited liability company, is enjoined from violating Health and Safety Code section 43153, including, but not limited to, selling or offering to sell new motor vehicles or new motor vehicle engines, including, but not limited to, motorcycles, scooters and all-terrain vehicles to California residents or businesses without obtaining the proper certification from the State Air Resources Board;
- 4. RICHARD WANG, aka Kheng Chan Voong, Richard Chan Voong, and Richard Kheng Chan, is enjoined from violating Health and Safety Code section 43151, including, but not limited to, importing, delivering, purchasing, receiving, or acquiring new motor vehicles or new motor vehicle engines, including, but not limited to, motorcycles, scooters and all-terrain vehicles for use, registration, or resale in California without obtaining the proper certification from the State Air Resources Board;
- 5. RICHARD WANG, aka Kheng Chan Voong, Richard Chan Voong, and Richard Kheng Chan, is enjoined from violating Health and Safety Code section 43152, including, but not limited to, importing, delivering, purchasing, receiving, or acquiring new motor vehicles or new motor vehicle engines, including, but not limited to, motorcycles, scooters and all-terrain vehicles intended for us in California, for sale in California, or for registration, leasing or rental in California, without obtaining the proper certification from the State Air Resources Board; and
- 6., RICHARD WANG, aka Kheng Chan Voong, Richard Chan Voong, and Richard Kheng Chan, is enjoined from violating Health and Safety Code section 43153, including, but not limited to, selling or offering to sell new motor vehicles or new motor vehicle engines, including, but not limited to, motorcycles, scooters and all-terrain vehicles to California residents or businesses without obtaining the proper certification from the State Air Resources Board.
