This SETTLEMENT AGREEMENT AND RELEASE (hereinafter "Agreement") is entered into between the STATE OF CALIFORNIA AIR RESOURCES BOARD (hereinafter "ARB") 1001 I Street, Sacramento, California 95814, and NEW SUNSHINE TRANSPORTATION INC. (hereinafter "NEW SUNSHINE"), 3900 Pelendale Ave. Ste. 420 Modesto, CA. 95356.

### I. RECITALS

- (1) California Health and Safety Code (HSC) section 44011.6 established the Heavy Duty Vehicle Inspection Program (HDVIP). It authorizes ARB to inspect on-road heavy-duty vehicles for excessive smoke emissions and engine tampering and to issue citations, accordingly. The program also requires the vehicle owner to repair its engines that exceed the prescribed ARB smoke opacity standards, perform a post-repair opacity test, and submit proof of repairs and any assessed penalties under the Regulations of the Heavy-Duty Smoke Inspection Program, chapter 3.5, sections 2180-2188, title 13 California Code of Regulations (CCR).
- (2) HSC section 43701 provides that ARB shall adopt regulations that require owners or operators of heavy-duty diesel motor vehicles to perform regular inspections of their vehicles for excessive smoke emissions.
- (3) Title 13 CCR, section 2190 *et seq*. was adopted under the authority of HSC section 43701 and, with limited exceptions, which are not applicable here, apply to all heavy-duty diesel powered vehicles with gross vehicle weight ratings greater than 6,000 pounds that operate on the streets or highways within the State of California.
- (4) Title 13 CCR, section 2190 et seq. authorize the Periodic Smoke Inspection Program (PSIP) which requires the owners and operators of California based vehicle fleets of two or more heavy duty diesel motor vehicles with gross vehicle weight ratings greater than 6,000 pounds that operate on the streets or highways within the State of California to conduct annual smoke opacity inspections of their vehicles that are four years older than the model year of the vehicle's engine.
- (5) Title 13 CCR, section 2192(a) requires inter alia that the owner of the vehicle "[t]est the vehicle for excessive smoke emissions periodically according to the inspection intervals specified in section 2193(a), (b), and (c)", "[m]easure the smoke emissions for each test...", "[r]ecord the smoke test opacity levels and other required test information as specified in section 2194..." and "[k]eep the records specified in section 2194 for two years after the date of inspection."
- (6) HSC section 43016 states, "Any person who violates any provision of this part, or any order, rule, or regulation of the state board adopted pursuant to this part, and for which violation there is not provided in this part any

other specific civil penalty or fine, shall be subject to a civil penalty of not to exceed five hundred dollars (\$500.00) per vehicle."

- (7) The ARB considers testing, measuring, recording, and recordkeeping to be critical components in reducing excessive smoke emissions from these heavy-duty vehicles.
- (8) ARB contends NEW SUNSHINE failed to test, measure, record, and maintain records of smoke emissions from its fleet of heavy-duty diesel vehicles for years 2011 and 2012 in violation of title 13 CCR, sections 2190 et seq.
- (9) In order to resolve these alleged violations, NEW SUNSHINE has taken, or agreed to take, the actions enumerated below under "TERMS AND RELEASE". Further, the ARB accepts this Agreement in termination and settlement of this matter.
- (10) In consideration of the foregoing, and of the promises and facts set forth herein, the parties desire to settle and resolve all claims, disputes, and obligations relating to the above-listed violations, and voluntarily agree to resolve this matter by means of this Agreement. Specifically, the ARB and NEW SUNSHINE agree as follows:

#### II. TERMS AND RELEASE

In consideration of the ARB not filing a legal action against NEW SUNSHINE for the alleged violations referred to above, and NEW SUNSHINE'S payment of the penalties set forth in section 1 below, the ARB and NEW SUNSHINE agree as follows:

(1) Upon execution of this Agreement, NEW SUNSHINE shall pay a civil penalty of \$8.625.00. Payment shall be made in check form as described below, and payments shall be made by the due dates as described below beginning on **November 30, 2013**.

- (2) Effect of Untimely Payment. If any payment is more than 15 days late, the entire remaining balance becomes immediately due and payable. In addition, if the Attorney General files a civil action to enforce this settlement agreement, NEW SUNSHINE shall pay all costs of investigating and prosecuting the action, including expert fees, reasonable attorney's fees, and costs.
- (3)It is agreed that if NEW SUNSHINE, including its subsidiary or parent company, at any time becomes insolvent, or makes an assignment for the benefit of creditors or similar action adversely involving NEW SUNSHINE, its subsidiary, or parent company, or a proceeding or petition under any bankruptcy, reorganization, arrangement of debt, insolvency, readjustment of debt, or receivership law or statute is filed by or against NEW SUNSHINE, its subsidiary, or parent company, or a trustee in bankruptcy. custodian, receiver or agent is appointed or authorized to take charge of any of NEW SUNSHINE'S, its subsidiary, or parent company's properties, or if any deposit account or other property of NEW SUNSHINE, its subsidiary, or parent company be attempted to be obtained or held by writ of execution, garnishment, attachment, condemnation, levy, forfeiture or other legal process, or NEW SUNSHINE, its subsidiary, or parent company takes any action to authorize any of the foregoing, the entire remaining balance becomes immediately due and payable without notice or demand.
- (4) It is further agreed that the penalties described in "Terms and Release", paragraph 1 are punitive in nature, rather than compensatory.

Furthermore, the penalty is intended to deter and punish NEW SUNSHINE for violations of state environmental statutes, and these penalties are payable to and for the benefit of ARB, a governmental unit. Therefore, it is agreed that these penalties imposed on NEW SUNSHINE by ARB arising from the facts described in recital paragraphs 1 – 8 are non-dischargeable under 11 United States Code § 523 (a)(7), which provides an exception from discharge for any debt to the extent such debt is for a fine, penalty or forfeiture payable to and for benefit of governmental unit, and is not compensation for actual pecuniary loss, other than certain types of tax penalties.

- (5) NEW SUNSHINE shall comply with one or both of the following options to attend the California Council on Diesel Education and Technology (CCDET I) class, (SAE J1667 Snap Acceleration Smoke Test Procedure for Heavy-Duty Diesel Powered Vehicles) as described on the ARB webpage at <a href="http://www.arb.ca.gov/enf/hdvip/ccdet/ccdet.htm">http://www.arb.ca.gov/enf/hdvip/ccdet/ccdet.htm</a>. This class is conducted by various California Community Colleges and instructs attendees on compliance with the PSIP, ECL and the HDVIP.
  - (a) NEW SUNSHINE shall have the fleet maintenance manager (or equivalent) and all staff performing opacity tests for compliance with PSIP and the HDVIP attend the CCDET I class. Proof of CCDET I completion shall be provided to ARB within six months of the date of this Agreement and be maintained in each applicable employee's file for the term of his or her employment.
  - (b) If NEW SUNSHINE uses a contractor to perform the annual smoke opacity testing required under the PSIP, in addition to having the fleet maintenance manager (or equivalent) attend the CCDET I course, NEW SUNSHINE shall obtain proof that the contractor's staff conducting the smoke opacity tests completed the CCDET I course within the past four years. This proof of CCDET I completion shall be provided to ARB with PSIP records as required by this Agreement and be maintained with the annual PSIP records.
- (6) NEW SUNSHINE shall comply with one or both of the following options to attend the CCDET II class (Diesel Exhaust After Treatment and Maintenance), described on the ARB's webpage <a href="http://www.arb.ca.gov/enf/hdvip/ccdet/ccdet.htm">http://www.arb.ca.gov/enf/hdvip/ccdet/ccdet.htm</a>. This class is conducted by various California Community Colleges and instructs attendees on California's emission regulations and the proper care and maintenance of diesel exhaust after-treatment systems (DEATS).
  - (a) NEW SUNSHINE shall have the fleet maintenance manager (or equivalent) and all staff responsible for maintenance of DEATS attend the CCDET II class. Proof of CCDET II completion shall be provided to ARB within six months of the date of this Agreement and also be



maintained in each applicable employee's file for the term of his or her employment.

- (b) In case NEW SUNSHINE uses a contractor for the maintenance of DEATS, in addition to having the fleet maintenance manager (or equivalent) attend the CCDET II course, NEW SUNSHINE shall obtain proof that the contractor's staff maintaining the DEATS device(s) completed the CCDET II course within the last four years. This proof of the CCDET II completion shall be provided by NEW SUNSHINE to the ARB within six months of the date of this settlement and be maintained with the DEATS installation and maintenance records.
- (7) NEW SUNSHINE shall not violate HSC sections 43701 et seq., and 44011.6. and title 13 CCR. Section 2190 et seq. or any other provision of law under the jurisdiction of the ARB.
- (8) NEW SUNSHINE shall not violate the Drayage Truck Regulation, as codified in Title 13, CCR, section 2027.
- (9) NEW SUNSHINE shall not dispatch drayage trucks that are not compliant with the emission standards set forth in the Drayage Truck Regulation or drayage trucks that are not registered with the DTR. The ARB reserves the right to audit the dispatch records of NEW SUNSHINE for compliance with Title 13, CCR, section 2027 (d) (5) any time in the future.
- (10) NEW SUNSHINE shall not violate the Truck and Bus regulation as codified in title 13 CCR, section 2025.
- (11) NEW SUNSHINE shall submit copies of all PSIP compliance records for the years 2013 and 2014 to the ARB by January 31 of the following year. Copies shall be addressed to the attention of Mr. Ryman Simangan at the California Air Resources Board, Enforcement Division, P.O. Box 2815, Sacramento, CA 95812. The ARB reserves the right to visit your fleet location at any time to conduct compliance audits for the HDVIP and PSIP, or any other applicable ARB program.
- (12) NEW SUNSHINE shall complete Low NOx Software Upgrades (reflash) on all applicable heavy-duty diesel engines operating in California and report to the ARB within 45 days of this agreement.
- (13) Each 1974 or newer diesel powered heavy-duty vehicle in the NEW SUNSHINE fleet shall comply with the emission control label (ECL) requirements set forth in the title 13 CCR section 2183(c).
- (14) NEW SUNSHINE shall instruct all employees who operate diesel-fueled vehicles to comply with the idling regulations set forth in title 13 CCR section 2485, within 45 days of this Agreement.

- (15) This Agreement constitutes the entire agreement and understanding between ARB and NEW SUNSHINE concerning the subject matter hereof, and supersedes and replaces all prior negotiations and agreements between ARB and NEW SUNSHINE concerning the subject matter hereof.
- (16) No agreement to modify, amend, extend, supersede, terminate, or discharge this Agreement, or any portion thereof, is valid or enforceable unless it is in writing and signed by all parties to this Agreement.
- (17) Severability. Each provision of this Agreement is severable, and in the event that any provision of this Agreement is held to be invalid or unenforceable, the remainder of this Agreement remains in full force and effect.
- (18) This Agreement shall be interpreted and enforced in accordance with the laws of the State of California, without regard to California's choice-of-law rules.
- (19) This Agreement is deemed to have been drafted equally by the Parties; it will not be interpreted for or against either party on the ground that said party drafted it.
- (20) Senate Bill 1402 (Dutton, Chapter 413, statutes of 2010) requires the ARB to provide information on the basis for the penalties it seeks (see Health and Safety Code section 39619.7). This information, which is provided throughout this settlement agreement, is summarized here:

The manner in which the penalty amount was determined, including a per unit or per vehicle penalty.

Penalties must be set at levels sufficient to discourage violations. The penalties in this matter were determined in consideration of all relevant circumstances, including the eight factors specified in HSC sections 42403 and 43024.

#### **PSIP Violations**

The per vehicle penalty for the PSIP violations involved in this case is a maximum of \$500.00 per vehicle per violation per year. The penalty obtained for the PSIP violations involved in this case is \$8,625.00 for 23 violations, or \$375.00 per vehicle per violation. The penalty was discounted based on the fact this was a first time violation and the violator made diligent effort to comply and cooperate with the investigation.

Bis. Z.

The provision of law the penalty is being assessed under and why that provision is most appropriate for that violation.

#### **PSIP Violations**

The penalty provision being applied to the PSIP violations is HSC section 43016 because NEW SUNSHINE failed to test, measure, record, and maintain records of smoke emissions from its fleet of heavy duty diesel vehicles for the years 2011 and 2012 in violation of the PSIP regulation in title13 CCR sections 2190 *et seq*, for 23 violations. Since the PSIP regulation was adopted pursuant to authority granted in Part 5 of Division 26 of the HSC and since there is no specific penalty or fine provided for PSIP violations in Part 5, HSC section 43016 is the applicable penalty provision.

Is the penalty being assessed under a provision of law that prohibits the emission of pollution at a specified level, and, if so a quantification of excess emissions, if it is practicable to do so.

### **PSIP Violations**

The PSIP provisions cited above do prohibit emissions above a specified opacity or level of g/hp-hr. However, since the hours of operation of the non-compliant units involved and their individual emission rate are not known, it is not practicable to quantify the excess emissions.

- (21) NEW SUNSHINE acknowledges that ARB has complied with Senate Bill 1402 in prosecuting or settling this case. Specifically, ARB has considered all relevant facts, including those listed at HSC section 43024, has explained the manner in which the penalty amount was calculated, has identified the provision of law under which the penalty is being assessed and has considered and determined that this penalty is being assessed under a provision of law that prohibits the emission of pollutants at a specified level.
- (22) Penalties were determined based on the unique circumstances of this matter, considered together with the need to remove any economic benefit from noncompliance, the goal of deterring future violations and obtaining swift compliance, the consideration of past penalties in similar cases, and the potential costs and risk associated with litigating these particular violations. Penalties in future cases might be smaller or larger on a per unit basis.
- (23) The penalty was based on confidential settlement communications between ARB and NEW SUNSHINE that ARB does not retain in the ordinary course of business. The penalty is the product of an arms length

negotiation between ARB and NEW SUNSHINE and reflects ARB's assessment of the relative strength of its case against NEW SUNSHINE, the desire to avoid the uncertainty, burden and expense of litigation, obtain swift compliance with the law and remove any unfair advantage that NEW SUNSHINE may have secured from its actions.

(24) Now therefore, in consideration of the payment on behalf of NEW SUNSHINE to the California Air Pollution Control Fund and the Peralta Community College District, the ARB hereby releases NEW SUNSHINE and their principals, officers, directors, receivers, trustees, employees, assignees, subsidiary, parent corporations, agents, predecessors and successors from any and all claims, the ARB may have or have in the future based on the circumstances described in paragraph (1) through (8) of the Recitals. The undersigned represent that they have the authority to enter into this Agreement
