






Priority Populations



- Assembly Bill 1550
 - Disadvantaged communities (25%)
 - Low-income communities and households (5%)
 - Low-income communities and households within ½ mile of disadvantaged communities (5%)



- CARB sets investment targets for programs
- 74% of project dollars benefit priority populations



Cumulative Project Achievements



98.0 million metric tons carbon dioxide equivalent estimated greenhouse gas emissions reduction

1,079 transit agency projects funded, adding or expanding transit service

11,402 affordable housing units under contract

217,763 urban trees

928,000+ acres of land conservation or restoration

415,900+ rebates issued for zero-emission and plug-in hybrid vehicles



Fifth Investment Plan Background



- Identify priority investments to achieve multi-faceted State goals
- Dept. of Finance, CARB, and other State agencies collaborate on Triennial Investment Plan (IP) development
- Staff currently developing Fifth IP (2025-26 through 2027-28), due to the Legislature by January 2025
- Priority investment types identified in the IP do not guarantee funding but rather provide guidance to the Legislature on potential funding priorities



- Will provide a statewide Financing Assistance Program and expand the Clean Cars 4 All (CC4A) program to Air Districts that do not offer CC4A at the local level
- For Air Districts that have their own CC4A program
 - Collaboration opportunities
 - Cross promotion of programs & outreach support

March 19, 2024 Work Group Recap

- Program Name: Driving Clean Assistance Program
 - Program name originated from the local Financing Assistance pilot program, which was the inspiration behind the needs-based model of implementation that will be used in this new statewide program.

Regional Roll-Out Ideas

- Equity-based regional approach focusing on need & program burden by county:
 - Identify high-need counties in California & counties that experience a higher burden to participate in the program
 - Provide program services in these counties first, followed by others
 - Identify regional caps for incentive funding so that funding is available for all regions of California



Need Indicator Ideas & Options

- Indicators used to determine need by county:
 - Percentage of population that is 300% Federal Poverty Level or below
 - CalEnviroScreen scores
 - No current CARB-funded light-duty incentive program in area
 - Participation rates in previous CARB purchase incentive program



Program Burden Indicator Ideas & Options

- Indicators to determine program burden:
 - Public Elective Vehicle charging stations available per capita by county
 - Public Electric Vehicle charging stations installs planned by county
 - Distance to Bureau of Automotive Repair-certified dismantlers
 - Access to lending
 - New & used clean vehicle availability


