Background



Statewide Clean Cars 4 All and Financing Assistance

- A total of \$257.5 million allocated to this program to-date
- Will provide a statewide Financing Assistance Program and expand the Clean Cars 4 All (CC4A) program to Air Districts that do not offer CC4A at the local level
- For Air Districts that have their own CC4A program, this effort provides:
 - Collaboration opportunities
 - Cross promotion of programs & outreach support
- Will use a needs-based model for implementation that was approved in the Fiscal Year 2022-23 Funding Plan



Overview of Approved Needs-Based Model

· Goals:

- Be more intentional in supporting lower-income consumers
- Provide more tailored assistance to priority applicants
- Keep the program open year-round

· Criteria:

- Disadvantaged community (DAC) or Low-Income Community residency
- Income level
- Needs for financial counseling or credit repair
- Categorical eligibility (Medicaid, SSI, CAPI, CalWorks, HUD/Section 8, etc.)



Needs-Based Implementation

Regular Applicants Tier III

Low-Income (<300% FPL*)

+30 Days Application Processing Goal

Close at 50% of funds remaining

Priority Applicants Tier II

<225% FPL Income Categorical Eligibility Need Credit Repair

Expedited Application Processing (15 - 30-Day Goal)

Close at 25% of funds remaining

Priority Applicants Tier I

DAC/Low-Income Community Residents

Immediate Application Processing (10 - 15-Day Goal)

Open All Year

*Federal Poverty Level



Solicitation & Grantee Selection

- Solicitation Open February 22, 2023
- Solicitation Closed March 24, 2023
 - 4 applications received
 - Beneficial State Foundation, Community Housing Development Corporation, The Center by Lendistry, and Hunts Motors
- Solicitation Scoring and Selection Period March 24 June 14, 2023
- Approved Grantee Selection June 14, 2023
 - Community Housing Development Corporation (CHDC) selected
- Grant Signed November 14, 2023
 - CHDC officially begins work on the program
- Official Grant Kickoff Meeting December 15, 2023



Grantee: Community Housing Development Corporation (CHDC)

- Community Housing Development Corporation (CHDC) is a community-based organization (CBO) in North Richmond founded in 1990 and is a full-service housing development corporation as well as providing supportive services such as financial and credit counseling and community outreach.
- Administrator for the local Financing Assistance pilot offered in the Bay Area and parts of Sacramento and Yolo Counties.
- Their proposal had a very strong partnership plan with letters of intent from key partners as well as many letters of support from a diverse group of stakeholders, community-based organizations (CBOs), and financial institutions.
- Detailed outreach plan to partner with a diverse network of CBOs and tribal communities across the state.



Joint Program Name: Driving Clean Assistance Program

- Program name originated from the local Financing Assistance pilot program administered by CHDC, starting in 2016
 - The local Financing Assistance pilot closed in 2023 leaving the program name available for re-use.
 - The local Financing Assistance pilot's high-touch, consumer-focused model was the inspiration behind the needs-based model of implementation that will be used in this new statewide program.
- Incorporates stakeholder feedback to simplify incentives landscape and not introduce a new program name
- Provides clear and concise branding to assist in outreach

DCAP Roll-Out Ideas

- Equity-based regional approach focusing on need & program burden by county:
 - Identify high-need counties in California & counties that experience a higher burden to participate in the program
 - Provide program services in these counties first, followed by others
 - Identify regional caps for incentive funding so that funding is available for all regions of California



Need Indicator Ideas & Options

- Percentage of population that is 300% FPL or below
- CalEnviroScreen scores
 - Pollution burden, population characteristic, and combined
- No current CARB-funded light-duty incentive program
- CVAP & CVRP Rebate Now redeemed per capita by county



Program Burden Indicator Ideas & Options

- Public EV charging stations available per capita by county
- Distance to BAR-certified dismantlers
- Access to lending
