For compliance with the CHC Regulation, individuals with any level of valid CCDET certification may perform CHC opacity testing. All opacity testing for CHC regulatory compliance must be completed in accordance with subsection (k) of the [CHC Regulation](#), including the adaptation of SAE J1667 as outlined in subsection (k)(1)(B).

In addition to the CCDET IV-certified vendors above, CHC operators seeking vendors for opacity testing CHC engines may also refer to CARB’s land-based [Commercial Smoke Tester Courtesy List](#). However, please note that CARB CHC Program staff have not verified if any of the listed land-based commercial smoke testers are currently CCDET-certified for opacity testing or whether they are currently able and willing to test engines in CHC applications.
