Project Goals

- Attain a comprehensive dataset of criteria pollutants, toxic air contaminants, and greenhouse gases.
- Complement AB 617 activities by engaging communities beyond those currently selected under the Community Air Protection Program.
- Create a data portal for the public to access and visualize SMMI mobile monitoring data.

Mapping Strategy


Broad Area Mapping

(Aclima fleet + partner labs)








Air Pollution Sources with Pollutants Measured by SMMI

- Metal working and metal finishing industries
- Foundries and secondary smelters
- Sterilization facilities
- Commodity fumigators
- Oil and gas operations
- Chemical manufacturing
- Animal feed lots
- Rendering facilities

- Ports
- Airports
- Railyards
- Warehouse and distribution centers
- Other large permitted sources (wastewater treatment, landfills, cement plants)
- Commercial activities (auto repair and auto body, dry cleaner, paint shop, printing shop)











Data Visualization and Analysis



Publicly accessible data visualizations


Example features

- Upfront summaries
- Hotspot/source identification
- Comparative analysis

Underlying data will be publicly available.



Your Participation Will Help Inform the Final Monitoring Plans



- Co-designed parameters include:
 - Sources or locations of concern
 - Geographic definition of "communities"
 - Priority weighting of health and socioeconomic data sets
- Community engagement will drive this through the development of Community Air Monitoring Plans (CAMPs)

Project Expert Group (PEG)

Who will be in the PEG?

- Experts will be recruited from across the state to inform and guide the SMMI
- Community members directly representing the Consistently Nominated Communities (CNCs) will be at least 50% of the group

What does the PEG do?

- 1) Serve as advisors for the SMMI in key areas
 - Support community engagement
 - Development of the Community Engagement Plan
 - Monitoring prioritization to address community concerns
- 2) Participate in meetings
